

Action Plan for Orange Day, 25 July 2016 Violence against women and reducing social inequalities

The United Nations Secretary-General's Campaign *UNITE to End Violence against Women* has proclaimed the 25th of each month as "Orange Day", a day to raise awareness and take action to end violence against women and girls. As a bright and optimistic colour, orange represents a future free from violence against women and girls, for the UNITE Campaign. Orange Day calls upon activists, governments and UN partners to mobilize people and highlight issues relevant to preventing and ending violence against women and girls, not only once a year, on 25 November (the International Day for the Elimination of Violence against Women), but every month.

In 2016, a new global development agenda was accepted by all countries and is applicable to all. Through its 17 goals and 169 targets, the 2030 Agenda for Sustainable Development, an agenda for global action for the next 15 years, addresses the three dimensions of sustainable development: the economic, social and environmental. The Agenda recognizes gender equality and the empowerment of women as a key priority and pledges that "no one will be left behind". Goal 5 of the agenda aims to "Achieve gender equality and empower all women and girls" and includes specific targets to eliminate all forms of violence against women and girls. All goals are integrated and indivisible, therefore their achievement is also fully dependent on ensuring parallel and interconnected implementation of the efforts to prevent and eliminate violence against women and girls. For this reason, throughout 2016, the UNITE campaign through its Orange Days will highlight specific Sustainable Development Goals as they relate to violence against women and girls. This Orange Day, 25 July, the UNITE campaign will highlight Goal 10: Reduce inequality within and among countries.

Sustainable Development Goal 10: Reduce inequality within and among countries

SDG 10 focuses on reducing inequalities between countries. In order to achieve this, a key target

highlighted under Goal 10 is to ensure equal opportunity and reduce inequalities of outcome at the

national level, including gender discrimination, by eliminating discriminatory laws, policies and

practices. In many countries, gender inequalities are enshrined openly in discriminatory laws,

affecting the social status of women and creating an environment in which women are at

heightened risk from violence.

Discrimination, inequality and violence against women

Although international laws and standards require all states to ensure equal rights, women may be

denied equal rights to men in areas such as property and inheritance, nationality, health, education,

freedom of movement, and protection from violence. In some countries, women cannot drive,

inherit property or give evidence in Court. Laws explicitly mandating "wife obedience" still govern

marital relations in many States, while in others, women's rights to divorce or remarry may be

limited.

Where discriminatory laws exist, women are institutionalized as second class citizens, their

opportunities to be economically independent and make decisions about their own lives are

reduced, and they are at greater risk from violence and their options when facing a violent situation

are reduced. The consequences of violence against women and girls can also exacerbate social

inequality, in some cases leaving women and girls unable to complete their education or to

contribute fully in the work place, family or economy. Violence against women and girls also comes

at a substantial cost to societies, including health services, justice systems and social services.

The elimination of discriminatory laws and the introduction of comprehensive legislation to

prevent, respond to and punish all forms of violence against women and girls which are effectively

implemented is therefore a critical step towards ending violence against women and girls, and also

in reducing social inequalities.

Suggested Orange Day Activities

Wear orange on 25 July to show your support for ending violence against women and girls.
